Credit Recovery Summer Session

Monday, June 6, 2022 to Friday, July 1, 2022.

Credit Recovery courses will be provided via a computer-based program designed to diagnose skills and knowledge the student has already achieved and work on areas they have not mastered. All students will be working at their individual level.

Most core academic subjects are offered through the Credit Recovery Program.

All Credit Recovery registrations must be signed by a counselor.

**GENERAL STATEMENTS AND
POLICIES**

Disciplinary Statement -

All students will be expected to adhere to the rules stated in the student code of conduct. Each student will be furnished with a copy of the code of conduct and will be required to sign a verification sheet, which acknowledges receipt of the furnished code. Violations of the code of conduct could result in the student missing part or all of the time remaining in the school day. **Disciplinary time is deducted from the four (4) hour attendance limit. If disciplinary action results in a loss of time, an attempt will be made to notify the student's home.**

Attendance Statement -

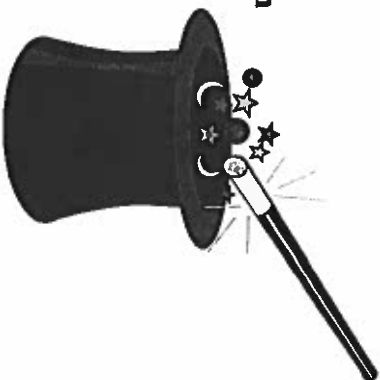
Good attendance is essential for a quality learning experience. Since the work is highly concentrated in fewer days than a regular school year, faithful attendance is required for credit to be awarded. Students who miss more than four (4) hours per semester of classroom instruction in a course will be dismissed and will not be awarded credit for the course. It is essential that students and their families plan their summer activities before the student registers for summer school. Situations such as court appearances, doctor or dentist appointments, which take the student away from the class for more than four (4) instructional hours will prevent his or her earning the credit.

Punctuality is also expected. Three (3) tardy marks will be counted as absence of one (1) instructional hour. Any time missed because of disciplinary infractions will be counted against the four (4) hour time limit.
